**CONSTRUCTION UPDATE**  
**AUGUST 11, 2023**

Gauga County Engineer, Joe Cattell, PE, PS, has announced the start/continuance of construction on the following projects in Gauga County.

- ***Auburn Township, Various Roads:*** Work has commenced on The Asphalt Resurfacing of Various Roads; including Longview Trail, Bridge Creek Trail, Frostwood Drive, Golden Pond Drive and Sanctuary Drive. Traffic is being maintained, expect delays.
- ***Auburn and Bainbridge Township, Washington Street:*** Work has commenced on The Asphalt Resurfacing of Washington Street from S.R. 306 to Bainbridge Road. Traffic is being maintained, expect delays.
- ***Bainbridge Township, Washington Street:*** Work has commenced on The Asphalt Resurfacing of Washington Street from the Cuyahoga County Line to S.R. 306. Traffic is being maintained, expect delays.
- ***Chester Township, Various Roads:*** Work has commenced on The Asphalt Resurfacing of Various Roads; including Brook Lane, Walnut Ridge Road, West Walnut Ridge Road and Evergreen Drive. Traffic is being maintained, expect delays.
- ***Chester Township, Various Roads:*** Work has commenced on The Chip Seal of Various Roads; including Sperry Road, Heath Road and Hillcrest Road. Traffic is being maintained, expect delays.
- ***Hambden Township, Brakeman Road:*** Work has commenced on The Asphalt Resurfacing of Brakeman Road from S.R. 166 to the Lake County Line. Traffic is being maintained, expect delays.
- ***Montville Township, Hautala Road:*** The Asphalt Resurfacing of Hautala Road from Clay Street to S.R. 528 will begin on/about August 15th and last approximately 14 days. Traffic will be maintained, expect delays.
- ***Munson Township, Sherman Road:*** Work has commenced on The Road Widening of Sherman Road from Heath Road to Fowlers Mill Road. The road is closed to thru traffic for approximately 3 weeks; detour route is posted. Expect delays if you live within the project limits.
- ***Newbury Township, Addington Court:*** The Asphalt Resurfacing of Addington Court will begin on/about August 16th and will last approximately 21 days. Traffic will be maintained, expect delays.
- ***Russell Township, Various Roads:*** Work has commenced on The Asphalt Resurfacing of Various Roads; including Blackford Drive, Clarion Drive, Hazelwood Drive, Sylvan Road, Memory Lane, Birchmont Drive, Fernwood Road, Laurel Road, Spring Valley Drive and Hillbrook Drive. Traffic is being maintained, expect delays.
- ***Thompson Township, Moseley Road:*** Work has commenced on The Asphalt Resurfacing of Moseley Road from Clay Street to S.R. 528. Traffic is being maintained, expect delays.
